WEP at the 6th Global Environment Facility (GEF) Assembly

At the closing session of the GEF 6th Assembly held in Vietnam from 24-29 June, 2018, our Executive Director, Dr. Priscilla Achakpa presented the outcomes of the discussions held during the Civil Society Forum on behalf of the Civil Society Organizations.

"She highlighted recommendations to the GEF Secretariat and the wider Partnership from the 120 CSOs present at the Assembly, and 538 CSOs in the wider GEF-CSO Network on, *inter alia*:

- the need to recognize that partnerships between the GEF and CSOs are key for achieving transformational change;
- establishing a multi-stakeholder dialogue platform to build trust and collaborative approaches;
- that the GEF agencies and OFPs should have greater inclusion of CSOs in project development and implementation; and
- enhanced support to the GEF-CSO network to help achieve the GEF-7 replenishment targets."

Capacity development training for WEP's Sub-Recipients

Women Environmental Programme (WEP) on the 25th-29th June, 2018, organized a Capacity Development Training for her Sub-recipients (SRs) under the project: Connecting Women and Youths in Violent Extremist Prone Areas through Empowerment and Skill Acquisition. The event took place at Smile View Hotels, David Mark By-Pass Makurdi, Benue State. The aim of the training was to strengthen the capacity of the SRs to effectively deliver on the project and achieve their organizational goals.

In the development community today, capacity development is seen as the engine of human development. WEP sees her engagements with SRs on various projects not just as a working partnership but one that should see them emerging as better and more efficient entities. Participants were trained on topics ranging from Leadership Skills, Project Design and Management, Monitoring and Evaluation, Effective Communication, Effective Reporting, Resource Mobilization, Strategic Planning, Organizational Governance, Sustainability Planning, Human Resource Management, to Use of Social Media as well as Accounting Procedures.
